AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that BLAYTIN DUANE TAUNTON, and PATRICK ALLEN SPIKES, between the 23rd day of July, 2018 and the 8th day of January, 2019, in said County and State, did or acted as a principal, in violation of Florida Statute 812.019(1) and 777.011, traffic in, or endeavor to traffic in, property that BLAYTIN DUANE TAUNTON, and PATRICK ALLEN SPIKES knew or should have known was stolen, to-wit: a costume or costumes or clothing or wigs or any combination thereof.

COUNT TWO

ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, or ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that BLAYTIN DUANE TAUNTON, and PATRICK ALLEN SPIKES, between the 23rd day of July, 2018 and the 8th day of January, 2019, in said County and State, did or acted as a principal, in violation of Florida Statute 812.014(2)(c)(3) and 777.011, pursuant to one scheme or course of conduct, knowingly obtain or use, or endeavor to obtain or use a costume or costumes or clothing or wigs or any combination thereof, of a value of TEN THOUSAND DOLLARS (\$10,000) or more, the property of another, to-wit: WALT DISNEY WORLD, as owner or custodian thereof, with the intent to temporarily or permanently deprive said owner or custodian of a right to the property or a benefit therefrom, or to appropriate the property to the defendants' own use or to the use of a person not entitled thereto.

COUNT THREE

ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, or ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that BLAYTIN DUANE TAUNTON, and PATRICK ALLEN SPIKES, between the 23rd day of July, 2018 and the 8th day of January, 2019, in said County and State, did or acted as a principal, in violation of Florida Statute 810.02(4)(a) and 777.011, enter or remain in a structure, located in the vicinity of 4601 N. World Drive, Orlando, Florida (Magic Kingdom), in the County and State aforesaid, the property of WALT DISNEY WORLD, as owner or custodian thereof, with the intent to commit an offense therein, at a time when the said premises were not open to the public, nor were the defendants licensed or invited to enter or remain.

COUNT FOUR

ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, or ARAMIS D. AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that PATRICK ALLEN SPIKES, between the 23rd day of July, 2018 and the 8th day of January, 2019, in said County and State, did, in violation of Florida Statute 810.02(4)(a), enter or remain in a structure, located in the vicinity of 1610 Avenue of the Stars Ave., Orlando, FL (EPCOT), in the County and State aforesaid, the property of WALT DISNEY WORLD, as owner or custodian thereof, with the intent to commit an offense therein, at a time when the said premises were not open to the public, nor was the defendant licensed or invited to enter or remain.

COUNT FIVE



AYALA, State Attorney of the Ninth Judicial Circuit prosecuting for the State of Florida in Orange County, by and through the undersigned Designated Assistant State Attorney, under oath, CHARGES that PATRICK ALLEN SPIKES, on or about the 19th day of December, 2018, in said County and State, did, in violation of Florida Statutes 918.13(1)(a) and 777.04, knowing that a criminal trial, or proceeding, or an investigation by a duly constituted law enforcement agency was pending or was about to be instituted, attempt to alter, destroy, conceal or remove any record, document, or thing, to-wit: a cellular telephone and/or its contents, with the purpose of impairing its verity or availability in such proceeding or investigation.
